for Establishment and Operation of

Sports University of Haryana, Rai (Sonipat) invites sealed quotations from interested and eligible individuals/firms for establishment and operation of a “Health Point (Milk, Juice and Fruit Corner)” within the University campus, as per details given below:

1. Name of Facility:

Health Point (Milk, Juice and Fruit Corner)

2. Location:

Near Shooting Range / University Campus, Rai (Sonipat)

3. Time and place of Submission:

7 days from the date of publish i.e. 16.01.2026 (Upto 5 PM)

Room No. 22, General Branch, Shooting Range, Sports University of Haryana, Rai

4. Duration:

Initially for a period of one (01) year, extendable further based on satisfactory performance and approval of the University.

5. Scope of Work:

- Sale of milk, milk products, fresh fruit juices, shakes and seasonal fruits as approved by the University.
- Maintain proper hygiene, cleanliness and quality of items.
- Display approved rate list prominently.
- No sale of tobacco, alcohol, pan masala or any prohibited items.

6. Temporary Structure:

- A. Place will be provided by the University.
- B. The temporary structure / kiosk / booth required for operating the Health Point shall be installed by the selected vendor at his/her own cost. No permanent construction shall be allowed.

7. Eligibility:

- Minimum qualification: Matriculation.
- Age: 18 to 55 years.
- Experience in running similar outlet will be preferred.
- Valid FSSAI license is mandatory.
- Self-attested documents should be provided.

8. Selection:

Selection will be made by the University committee based on eligibility and quoted license fee.

9. Submission of Quotation:

The quotation should be submitted in a sealed envelope superscribed: “NIQ for Health Point (Milk, Juice and Fruit Corner)” and addressed to: The Registrar, Sports University of Haryana, Rai, Sonipat – 131029.

10. General Terms & Conditions:

- The selected vendor shall be required to deposit three (03) months’ advance rent with the Sports University of Haryana prior to commencement of operations. The advance rent shall be adjustable against future monthly rent and shall not carry any interest.
- If at any time the quality of milk, fruits, juices, or any other item sold at the Health Point (Milk, Juice and Fruit Corner) is found to be unsatisfactory, unhygienic, or not in conformity with the standards prescribed by the University, the Sports University of Haryana reserves the right to cancel/terminate the contract forthwith at any time without assigning any reason and without prior notice. In such a case, the decision of the University shall be final and binding on the vendor.
- The University reserves the right to accept or reject any or all quotations without assigning any reason.
