- 3. Deploy adequate manpower, furniture, and equipment for smooth operation.
- 4. Display rate list (approved by University) prominently.
- 5. Refrain from selling banned or restricted items (e.g., tobacco, alcohol, pan masala, etc.).
- Pay electricity charges based on sub-meter readings in addition to monthly rent and water charges.

## 5. Security Deposit

The successful bidder shall deposit ₹25,000/- (Rupees Twenty-Five Thousand only) as an interest-free Security Deposit within 10 days of award of contract. The EMD may be adjusted against the Security Deposit.

### 6. Duration of Contract

The lease term shall initially be for one year, extendable for further duration as mutual agreed based on satisfactory performance and approval by the University authorities.
