CORRIGENDUM

With reference to the Notice Inviting Quotation (NIQ) no. SUOH/Gen/2025/162 dated 18.09.2025 for Supply, Installation, and Commissioning of CCTV Surveillance System in the University Campus. A Pre-Bid Meeting was held on 25.09.2025, the following clarifications and amendments are issued based on vendor queries and may be read as follow in the original NIQ:

S. No.	Ammendments
1	Total NVR capacity supports 28 cameras, while 30 cameras are specified. 2 cameras to be treated as standby.
2	Inclusion of conduits/PVC channels for CAT6 and power cable laying. Conduits will be included.
3	Display devices will be included in NIQ.
6	At least 85 TB usable storage vs. 26 TB supported by current NVRs will be expanded.
7	To use higher port count PoE switches for scalability.
8	Main Gate entry cameras will have weather-resistant mounting accessories.

The relevant clauses of the main tender document shall be read as amended above.
